CATCH THE LOVESM

Construction broke the ceiling in July 2020 and on November 3, 2022, a ceremonial ribbon-cutting marked the grand reveal of the expansion of the four new floors at Joe DiMaggio Children's Hospital.

The expansion includes 72 patient rooms, two cardiac hybrid operating rooms, two surgical suites, intensive care and cardiac intensive care units, intraoperative MRI, play zones, rehabilitation, and family support areas.

The *Catch the Love* campaign fundraising effort generated over \$56 million dollars for the expansion, as a homage to Joe DiMaggio's Major League Baseball 56-game hitting streak.

The #MOMENT We Have Been Waiting For - Move-In Day!

On November 9, the official move into the new hospital expansion commenced. This herculean effort included transporting more than 55 patients to three separate floors over eight hours. The operation entailed 600+ hours of planning, a robust command center to ensure every single detail was seamlessly managed and an additional 50+ healthcare workers to safely move every patient and their family.

Rebuilding Strength

Intensive therapy at Memorial Rehabilitation Institute helped Cristina get moving again after a neurological disorder knocked her off her feet.

Cristina had just returned from a bike ride when her legs went numb. Her husband took her to Memorial Hospital Miramar, where the Memorial Neuroscience Institute team found that Cristina had transverse myelitis, or inflammation of the spinal cord.

She was admitted to Memorial Rehabilitation Institute at Memorial Regional Hospital South for intense physical and occupational therapy to recover as much strength, mobility and function as possible. Now, she and her husband are walking miles every day.

“When you have a team like the one Memorial has here, patients recover easily,” she says.

A Friend's Loving Gift

Ben had extreme swelling in his legs and feet, his heart was working at only 11% and his kidneys were failing. Slowly, his heart grew stronger, but he still needed a kidney.

Tia, a Memorial employee, knew Ben from church. She offered to help by donating one of her kidneys. Living donor transplants like this offer fewer complications and often last twice as long.

Now, Ben has his energy, strength and life back. “I got a second chance,” he says.

Back on the Court

When elite tennis athlete Brianna felt a sudden, sharp pain in her back and couldn't pick up or swing her tennis racket, she tried to rest and stretch. When that didn't work, she turned to the [U18] Sports Medicine team at Joe DiMaggio Children's Hospital.

An MRI revealed a stress fracture in her lower back. The team, including her physician Matthew Fazekas, MD, started her on a bracing treatment and physical therapy and supervised her return to tennis. Dr. Fazekas said the U18 team's multidisciplinary approach is crucial for success with athletes like Brianna.

Now, Brianna is back to reaching for her goals. "I want to become No. 1 in the world," she said.

Family Finds Answers, Deep Caring and Hope

"We went to so many hospitals throughout my whole life," Da'realis said. Even though Da'realis had been repeatedly hospitalized, Da'realis' mom said, "They never figured out what the problem was."

So she called Joe DiMaggio Children's Hospital. During his workup, it was discovered he had Kearns-Sayre syndrome, a genetic condition that can affect skeletal muscles, eyes and heart. It also indicated a very severe form of heart failure.

After discussions with the family, the team moved forward with an implantable heart pump. It had been used at other pediatric centers, but this was a first for Florida.

"It seems like each and every person and staff was handpicked just for patients like my son," concluded Lakesha, Da'realis' mom.

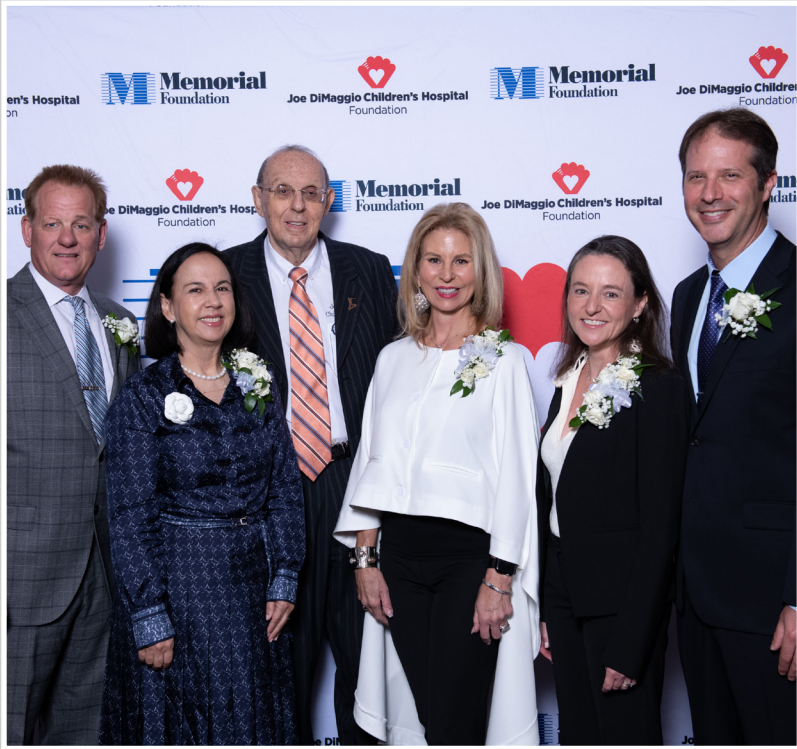

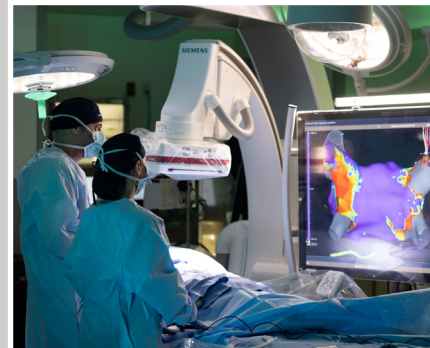

LEAP for Success Program

The **United Way of Broward County** has been a strong supporter of our Community Services programs for many years. One program which they have funded for the past four years is the LEAP for Success Program, an academic afterschool program for low-income minority children ages 3-4 which helps them prepare for a strong start in elementary school in all basic subjects. The program also offers wraparound case management for the families to help them take advantage of resources in the community. As of two years ago, **The A.D. Henderson Foundation** joined United Way in funding this program, to double the capacity of the classes. We are now serving 80 children and families per year, thanks to our generous supports.

Cancer Related Programs

Community Foundation of Broward has funded a collaborative research program between Memorial Cancer Institute and Florida Atlantic University which will create a biospecimen repository that will be used to reduce health disparities among minorities. **The American Cancer Society** has provided transportation assistance for both pediatric and adult cancer patients who are in danger of failing to comply with their prescribed treatment plan because they can't afford transportation to get to their appointments. They also provide lodging assistance for post-transplant patients in need who must stay close

to Memorial for follow up but can't pay the hotel bill. **Florida Breast Cancer Foundation** has funded image recovery items like wigs and lymphedema sleeves as well as tomosynthesis 3D mammograms for patients who otherwise could not afford them and would risk late diagnosis of breast cancer

Fundraising Groups

Fundraising groups are an important part of the Foundations' strategy, making it possible to reach our goals each year.

The **PINK ANGELS** of Memorial Foundation are a group of volunteers, many of them breast cancer survivors, dedicated to raising awareness and funds to support breast cancer patients and families through programs and services at the Memorial Breast Cancer Center. In 2022, the Pink Angels had a record-breaking year raising over \$350,000 through the Touch of Pink Party, 4th Annual Tennis Tournament, and other community initiatives. They have also committed funds for the new Memorial Cancer Institute building, set to open in late 2023.



The **DIAMOND ANGELS** of Joe DiMaggio Children's Hospital Foundation is a volunteer group formed in 2004. Their mission is to serve as advocates for Joe DiMaggio Children's Hospital and to support the hospital's vision of providing safe and high-quality, patient and family-centered care to all children and families in need regardless of ability to pay. The Fairy Tale Ball is their annual fundraiser.



After two years of postponements due to the pandemic, the 18th Annual Fairy Tale Ball - Adventures in the Jungle presented by UKG, made a much anticipated return on Saturday, November 12 at The Diplomat Beach Resort. Emceed by Doc Reno from Big 105.9 FM, over 800 guests enjoyed a craft cocktail reception, a spectacular silent auction, a lavish dinner, and then danced the night away with Kenny Metcalf as Elton and the Early Years Band - America's #1 Tribute to Elton John. It was a record-setting night, raising over \$850,000 for the children and families of Joe DiMaggio Children's Hospital.



The **CONINE COMMITTEE** is one of Joe DiMaggio Children's Hospital Foundation's longest standing fundraising groups. For nearly three decades, they have organized and implemented fundraising events, including the Conine All-Star Golf Classic and the Jeff Conine Celebrity Poker Classic. To date, these events have raised more than \$7 million dollars to fund the annual operating expenses of the Conine Clubhouse, a home-away-from-home to over 25,000 families with free-of-charge services while their child is a patient at Joe DiMaggio Children's Hospital. In 2022, the 28th Annual Conine All-Star Golf Classic hosted a tournament high of 184 players and raised an all-time high of \$345,000.



Foundation Events

The Foundations rely each year on an exciting schedule of special events to raise significant funds in support of Memorial's and Joe DiMaggio Children's Hospital's programs and services.
